<u>7STARS FOUNDATION</u>		<p>Offers grants of up to £2,500 to support challenged and vulnerable young people under the age of 16. Registered UK charities working in areas of deprivation and disadvantage with an annual turnover of less than £1.5 million are eligible to apply. Projects should aim to empower young people, provide immediate support, and address gaps in existing services by for example providing recreational activities, mentoring programs, and counselling sessions.</p> <p>There are two additional funding streams:</p> <ul style="list-style-type: none"> • Shine Bright Grants: Up to £1,500 to purchase educational, wellbeing, or recreational items for young people under 16. • Individual Funding: Up to £500 for young people who are represented by a safeguarding, legal, social, or outreach professional.
<u>AGNES HUNTER SCIO</u>	29th February 2024	<p>The Agnes Hunter Trust SCIO was established in 1954 to support registered charities delivering health and social welfare projects in Scotland. In 2021 the Trust converted to become a Scottish Charitable Incorporated Organisation (SCIO). The Trust now focuses on one key area of funding support - offering grants to charities that support disabled people in Scotland.</p> <p>Applicant charities may assist with a wide range or specific groups of people, for example those living with mental ill health, cancer, physical and sensory impairments and long-term health conditions, as well as people with learning disabilities, autistic people, and other neurodivergent people.</p> <p>In addition, the Trust is particularly keen to receive grant applications from the following:</p> <ul style="list-style-type: none"> • smaller charities meeting a demonstrable 'need' from their local community • causes that do not have a strong public profile, including new Scottish charities • charities developing innovative approaches, including pilot projects <p>The Trust operates two rounds of grants per calendar year: a Spring/Summer round – with applications submitted between early January to late February, and taken to the Board meeting in late May/ early June; an Autumn/Winter round – with applications submitted between late June to mid-August, and taken to the Board meeting in late November/early December.</p>
<u>AUSTIN AND HOPE PILKINGTON TRUST</u>	28 Feb 2024	<p>The Trust gives grants to registered charities that work in the UK. They focus on specific priorities every year. In rounds 1 and 2 they will consider applications that focus on projects that support and improve</p>

		<p>employment and training for disabled people. In rounds 3 and 4 they will consider applications that focus on: providing nutritious meals, food education, cooking skills, eliminating food waste.</p> <p>They only award grants to organisations registered with the Charity Commission or OSCR, or exempt from registration.</p> <p>They have four grant rounds per year. The dates for these are:</p> <ul style="list-style-type: none"> • Grant Round 1: 1 - 28 February • Grant Round 2: 1 - 30 April • Grant Round 3: 1 - 31 July • Grant Round 4: 1 - 30 September <p>Please apply only if your charity meets the relevant income and expenditure criteria. <p><u>BBC CHILDREN IN NEED – BIG SKY GRANT FUND</u></p>		<p>This new initiative will offer grants of up to £5,000 to support the emotional wellbeing and mental health of children aged 8-13 living in island and remote rural communities.</p> <p>Grants are for early support to prevent problems developing at a later stage and could be through things like sports groups, art classes, and youth clubs. This is also part of our commitment to funding grassroots organisations that provide vital positive relationships to support children and young people.</p> <p style="text-align: center;">The first phase of this fund in Scotland is for organisations based in Orkney, Shetland and the Western Isles.</p> <p style="text-align: center;">Applications will be by invitation only.</p> <p>BBC CiN Scotland are running information sessions and encourage organisations interested in applying (or curious to learn more!) to join us. The sessions will cover who the fund is for, what types of work it can support and how to apply. There will also be opportunities to ask questions and speak to the BBC CiN Scotland Grant Officers.</p> <p>The sessions will take place online via Zoom and are for organisations based in Orkney, Shetland and the Western Isles. <u>BRITISH GAS ENERGY TRUST - INDIVIDUALS AND FAMILIES FUND</u>	Sunday 31 March	The Fund, administered by the British Gas Energy Trust, provides eligible customers (no matter who your supplier is in the UK) with grants of up to £2,000 to clear domestic gas and electricity debts under £1,500 with their energy supplier. Customers of Boost, Eon, Eon Next, EDF, Scottish Power, Ovo, Octopus, SSE and Utilita should apply to their own respective funds. The fund may close earlier if all funding has been allocated.
<u>CABWI CHARITY</u>	19 Feb 2024	<p>Funding towards learning and development that enables young people and adults to gain additional skills and confidence to enter the labour market. Your project must do one or more of the following:</p> <ul style="list-style-type: none"> • Work directly with young people and adults people who are not in employment, training or education, (NEET) or at risk of becoming NEET, to improve their access to employment. • Work with individuals with complex barriers to employment to gain life skills and qualifications leading to employment. • Help ex-service people and ex-offenders to gain new skills, training and employment. • Have clear and well-established connections to employers who can offer meaningful work experience and/or employment. • Prepare and develop young people and adults who seek a career in the water, utilities and construction industries. <p>Registered charities, CIC, Co-operatives, Social enterprises, anywhere in UK can apply. <u>DPO CENTRE CHARITY AND COMMUNITY FUND</u>	31 Mar 2024	<p>The DPO Charity Fund provides access to data protection consultancy services at an 80% funded rate. Eligible charities can apply for funding towards:</p> <ul style="list-style-type: none"> • Information Asset Register and Data Mapping • Policy Drafting and Review • Impact Assessments and Gap Analysis • Data Protection Training • Data Sharing and International Transfers • Privacy-by-Design • Data Protection Readiness

<u>GARFIELD WESTON FOUNDATION</u>	Apply any time	Match funding grants up to £100,000 and more are available to registered charities to support a range of causes. Currently inviting applications relating to Youth, Welfare and Community. Grants can be used to support core operating costs, capital projects, equipment purchases, or for defined time-limited projects.
<u>MUSIC FOR ALL - COMMUNITY PROJECT FUNDING</u>	5pm on 1 April 2024	<p>At the Music For All Charity they believe that everyone should have the opportunity to learn to play music. They make grants available to address the musical needs of community music groups and educational organisations. Organisations, schools and individuals can apply.</p> <p>They support projects and initiatives taking place throughout the UK that all aim to bring music to their community and would benefit from a “helping hand” to fulfil their potential in becoming truly sustainable music programmes.</p> <p>Grants are available under a number of different categories, each with their own criteria and award amounts. <u>SEA CHANGERS - COASTAL FOUNTAIN FUND 2024</u>	23 February	<p>The purpose of the fund is to reduce the impact of single-use plastic water bottles on coastal habitats by funding communities to purchase water drinking fountains and install them for use by the public in busy or environmentally important areas. So far we've funded over 30 fountains around the UK with more coming soon!</p> <p>Grants of up to £2,500 are available, per applicant, towards the cost of a fountain.</p>
<u>THE HENRY MOORE FOUNDATION</u>	1 Mar 2024	<p>Henry Moore Grants continue Moore's legacy by supporting sculpture across historical, modern and contemporary registers and seeking to fund research that expands the appreciation of sculpture. <p>THE RS MACDONALD CHARITABLE TRUST: <u>SAFE SPACES YOUTH WORK FUND</u></p>	26th January	<p>This fund was created in response to the specific challenges which youth groups face around the prevention of—and alleviation of—risk of harm to children and young people. It will make small awards to enable youth groups to deliver better youth work to young people who are at risk or who have experienced ACE's (Adverse Childhood Experiences).</p> <p>Funds can be used for general youth work activity which creates safe spaces for young people who are at risk, as well as providing the opportunity to run issue-based programmes for young people affected by abuse and other Adverse Childhood Experiences, according to need.</p> <p>The maximum amount per award is £2,000.</p>

<u>ARNOLD CLARK COMMUNITY FUND</u>	n/a	Open to community groups and UK charities. Up to £1,000 is available to organisations that can provide immediate help to their local communities
<u>AVIVA COMMUNITY FUND – CROWDFUNDING REQUIRED</u>	Ongoing	Grants up to £50,000 are available for not-for-profit organisations in the UK who can raise their initial funding through a crowdfunding campaign for projects that address Aviva’s current themes of climate champions and financial empowerment.
<u>AWARDS FOR YOUNG MUSICIANS</u>	Anytime	Awards for Young Musicians supports outstanding young instrumentalists making music in any genre. If you can clearly show that you are talented and committed and that you need financial help with your music costs then you can apply for an Award of up to £2000. The average award in 2020 was £550. Young musicians aged between 5 and 17 years of age and are living and studying in the UK are eligible to apply.
<u>BAILLIE GIFFORD COMMUNITY AWARDS</u>	Ongoing	The fund aims to support local grassroots organisations working to address food insecurity and social isolation
<u>BARCLAYS COMMUNITY</u>	<u>Apply any time</u>	Grants up to £500 are available for community sports clubs and voluntary organisations to offer new football opportunities or expand existing programmes to include people in under-represented groups, particularly girls and people with protected characteristics.

Grants up to £15,000 are available for not-for-profit organisations and up to £120,000 for registered charities supporting children and young people aged 18 or under.
<u>BBC CHILDREN IN NEED: EMERGENCY ESSENTIALS REOPENED</u>	Apply any time	Grants are available to provide critical household items and clothing to support children and young people facing exceptional and difficult circumstances. Applications must be made by a pre-registered referrer.
<u>BENEFACT TRUST</u>		<p>Funding is now available under the following grants programmes:</p> <p><u>Community Impact Grants</u> A programme of funding aimed at supporting projects that directly address the social challenges faced by some of the most vulnerable communities in our society.</p> <p><u>Building Improvement Grants</u> For the essential repair and improvement of churches and Christian buildings.</p> <p><u>Heritage Skills for Christian Buildings Grants</u> Focused on the preservation of essential heritage skills and careers through apprenticeships, scholarships, and training courses.</p> <p><u>Methodist Grants</u> For building projects that support Methodist churches in their mission and ministry, with a particular focus on church growth, community engagement and accessibility.</p> <p><u>Roof Alarm Grants</u> To protect churches from metal theft.</p>

<u>BUSINESS CHARGEPOINT FUNDING</u>		To support the use of electric vehicles across Scotland, Transport Scotland offers grant funding to help organisations install electric vehicle (EV) charging infrastructure on their premises. The funding is distributed by Energy Saving Trust and is currently available for chargepoints that will only be used by occupiers, staff and visitors.
<u>BUSINESS ENERGY SCOTLAND: SME LOAN SCHEME</u>		Cashback grants of £20,000 and interest free loans up to £100,000 are available to charities, community organisations and social enterprises to install energy efficient systems, equipment or to upgrade building fabric such as energy efficient lighting. Free assessments are available.
<u>CANOE FOUNDATION</u>	31 January 2024	<p>The Foundation supports projects that increase access to canoeing. The fund aims to support community organisations to reduce their building energy costs and carbon emissions. The <u>Let's Do Net Zero Community Buildings Fund</u> is open now and is planned to run until the end of March 2025, subject to funding availability. Funding is available for many types of community building, including: community cafes, community hubs, faith buildings, public halls, community halls and centres. Grant funding is available for up to 80% of eligible costs up to a maximum of £80,000. New guidance now available.

<u>CHARLES HAYWARD FOUNDATION - OLDER PEOPLE - SMALL GRANTS</u>	n/a	Funds preventative and early intervention programmes being delivered at the community level which allow older people to stay in their own homes and remain independent. They are particularly interested in programmes which show some creativity in improving the quality of life of older people. Up to £7,000.
<u>CIRCULAR ECONOMY INVESTMENT FUND</u>	N/A	This fund, administered by Zero Waste Scotland, offers investment to SMEs based in Scotland for work that will help to deliver circular economy growth.
<u>CIRCULAR TEXTILES FUND</u>		This fund supports the development of circular supply chains across the textiles industry in Scotland to help businesses achieve net zero carbon emissions. Zero Waste Scotland is administering the fund, which is backed by the Scottish Government, to help reduce the environmental impact of textiles.
<u>CLIMATE ENGAGEMENT LAB – 2023 OPEN CALL FOR INNOVATION PARTNERSHIP</u>		Climate Outreach is looking for a new innovation partner organisation to reach and motivate specific audiences in the UK. The <u>Climate Engagement Lab</u> is looking to support an existing project that is engaging people who are concerned about politics and climate change, but aren't generally part of the climate conversation and are deeply and instinctively distrustful that 'elites' will do much to help. Through the partnership, they will provide free support for a group that's engaging working class communities on climate or climate-adjacent (i.e. transport, energy, food) projects. The chosen partner will get support to apply evidence-backed insights to their project, along with up to £3,000 to cover the costs of participation.
<u>COMMUNITY RIGHT TO BUY FUND</u>		The Community Right to Buy Fund provides financial support for community organisations in the Highlands and Islands of Scotland. The fund helps communities pay for professional services to help them register an interest in land or buildings under the Community Right to Buy legislation. These services could include legal title searches or help with mapping. Funding of up to £5,000 is available, to cover up to 80% of the eligible cost. Communities must be prepared to cover the rest of the cost from other sources. This support is unlikely to involve state subsidy, but this will be assessed on a case by case basis.
<u>CORRA FOUNDATION LOCAL SUPPORT FUND - NATIONAL DRUGS MISSION FUNDS</u>	Ongoing until funds are spent	The Local Support Fund (LSF) is for grassroots and community-based organisations in Scotland, which deliver frontline services to support people who use or used drugs, people who are in recovery and/or their families. To apply for this fund, you should meet the following criteria:

		<ul style="list-style-type: none"> You should have previously received funding through the Local Support Fund for one or two years. You should currently be delivering frontline services in Scotland, to support people who use drugs, people in recovery and/or their families. You will require funding to stabilise or increase capacity, extend services and provide further reach into the community. Your organisation should have an annual income of up to £500,000. You must be a registered charity, social enterprise, community group or other voluntary organisation that have independent governance and an asset lock. <p>Corra Foundation encourages applications from organisations supporting Black, Asian, and Minority Ethnic communities, and other under represented groups, to increase access to support.</p> <p>To apply, email the grants team for a chat about your project or call us on 0131 444 4020.</p>
<u>CORRA FOUNDATION - BOOST SMALL GRANTS</u>		<p>Boost small grants programme is for organisations supporting children and families in their local communities. It has been created to help groups that find the increases in basic running costs (for example utilities, salaries, transport) are making their work much more challenging. Boost will provide grants of £500-£3,000 to grassroots organisations and charities with a yearly income of up to £50,000 whose work benefits children and families.</p> <p>This fund aims to ensure accessible, supportive community-led activities remain available to children and families despite the challenges the cost of living poses for charities and community groups. Boost is delivered by Corra Foundation and is a partnership between the STV Children’s Appeal and Corra Foundation.</p>
<u>CREATIVE SCOTLAND - MADE IN SCOTLAND ONWARD INTERNATIONAL TOURING FUND</u>	Remains open until it is fully allocated	<p>The aim of the Onward International Touring Fund is to enable artists, bands and ensembles based in Scotland to take up new international touring opportunities for work programmed as a direct result of the inviting promoter seeing the work at the Edinburgh Festival Fringe. This fund exists to support costs linked to flights, freight, visas and the translation of marketing materials. Other costs are expected to be met by the inviting promoter.</p>
<u>CREATIVE SCOTLAND: FUTURE FUNDING FRAMEWORK</u>		<p>If you are a voluntary organisation delivering arts, creative and cultural activities, check the updated planning timetable for multi-year funding published this week by Creative Scotland. Their Open Fund also relaunches in October. Information sessions to follow.</p>

<p><u>CREATIVE SCOTLAND: OPEN FUND: SUSTAINING CREATIVE DEVELOPMENT</u></p>	<p>The fund is open all year round – with no deadlines</p>	<p>Grants up to £100,000 over one year are available for charities, organisations and groups involved in the arts, screen and creative industries to adapt, respond and sustain practice.</p> <p>The fund will continue to support organisations to deliver a wide range of creative activity. This includes funding for:</p> <ul style="list-style-type: none"> • a specific one-off project or production or • a period of creative research and development or • a longer term programme of work. <p>It can also support organisations to undertake business and organisational development that will:</p> <ul style="list-style-type: none"> • enhance their business sustainability through the development of new or more diverse income streams or • consider broader organisational development costs. <p>Eligible organisations can apply for funding between £1k and £100k for projects or programmes lasting up to 18 months.</p>
<p><u>CYCLING SCOTLAND: CYCLING FRIENDLY GRANTS</u></p>		<p>Grants up to £20,000 are available for community groups and voluntary organisations for local projects that will improve cycling facilities and increase the number of people cycling. Other funding programmes are available.</p>
<p><u>CYCLING TOURISM FACILITIES FUND (HIGHLANDS AND ISLANDS ENTERPRISE) MOVE YOUR CYCLING FACILITIES UP A GEAR</u></p>		<p>This fund is for businesses and community enterprises operating in the tourism sector to develop and enhance their cycle tourism facilities. The minimum grant is £5,000 up to a maximum of £25,000 for capital expenditure, which will cover up to 50% of total eligible project costs.</p> <p>Funding can be used towards a variety of capital projects including investing in fixtures, fittings, construction, adaptation, or upgrade of premises to improve cycling tourism facilities.
