Two funding streams are available:</p> <ul style="list-style-type: none"> <li>• Major projects - up to £30,000. Grants must form a significant portion of the total project costs (normally, at least 20% of the total project costs).</li> <li>• Small projects - up to £10,000 for projects with total costs of no more than £12,500.</li> </ul> <p>The grant is for capital funding only, not ongoing revenue funding.</p>

<a href="#"><u>EVENTSCOTLAND - NATIONAL EVENTS PROGRAMME</u></a>	<b>23 Jun 2025, 12pm</b>	<p>The National Events Programme is one of the core funds run by the EventScotland team, designed to assist in the delivery of the National Events Strategy, Scotland the Perfect Stage, and to contribute to the wider recovery of tourism and events in Scotland.</p> <p>The Programme is designed to support innovative new projects and activity at events. Events will need to align with the key impact areas outlined in our National Events Strategy and must also have delivery budgets of more than £20,000 and attract over 1,000 in-person attendees. Finally, they must showcase Scotland's key event and tourism assets.</p> <p>Round 54 of the National Funding Programme will close at 12 noon on Monday 23 June 2025. <a href="#"><u>MUSIC FOR ALL - COMMUNITY PROJECT FUNDING</u></a>	<b>27 June 2025</b>	<p>At the Music For All Charity they believe that everyone should have the opportunity to learn to play music. They make grants available to address the musical needs of community music groups and educational organisations.</p> <p>They support projects and initiatives taking place throughout the UK that all aim to bring music to their community and would benefit from a “helping hand” to fulfil their potential in becoming truly sustainable music programmes.</p> <p>Grants are available under a number of different categories, each with their own criteria and award amounts. <a href="#"><u><b>Standard Innovation Voucher Scheme (Scotland)</b></u></a>	<b>Ongoing</b>	<p>A scheme that aims to build relationships between SMEs (small to medium-sized enterprises) and HEIs (Higher Education Institutes) in Scotland by supporting collaborative projects that will lead to new products and processes that will benefit the business, the institution and the Scottish economy. A wide range of collaborative projects are eligible for support, including:</p> <ul style="list-style-type: none"> <li>• Developing new products and processes.</li> <li>• New service development.</li> <li>• Improved production processes.</li> <li>• Experimental testing and measuring.</li> </ul> <p>The award for an individual project is for between £1,000 and £7,500. This will be paid to the academic institution to offset the costs of the collaborative project.</p>
<a href="#"><u><b>THE HUGH FRASER FOUNDATION</b></u></a>	<b>1st August</b>	<p>The Foundation donates to registered charities active in arts and culture, medical and health, the environment, education, and support for the young, elderly, disabled, and underprivileged. The Trustees focus on projects in Scotland, especially where fundraising is challenging. Grants are only given to registered charities or community interest companies, not to individuals or highly-publicised national appeals. The Trustees may commit to grants over three years to support new initiatives.</p>

Young musicians aged between 5 and 17 years of age and are living and studying in the UK are eligible to apply.
