BANK OF SCOTLAND FOUNDATION		<p>Bank of Scotland Foundation, has announced the launch of its new five-year strategy - "Building a Brighter Future for Scotland." The strategy aims to fund, support and champion small and local charities that work towards improving the quality of life for some of Scotland's most vulnerable people.</p> <p>The first multi-year programme under the new strategy, Empower, will launch in early February, offering real security and certainty for charities. This programme will offer a three-year unrestricted grant of £150,000 (£50,000 per annum) and collaborating with Lloyds Banking Group, the Foundation also aims to identify opportunities to add strategic value for funded charities and help them grow stronger and thrive beyond the lifetime of their grant.</p> <p>Two further multi-year programmes will be launched later in the year. Energise is a multi-year grants programme supporting small and local charities that are closest to the real issues facing our communities. Available to new (and more established) charities this programme offers a two-year unrestricted grant of £20,000 (£10,000 per annum), enabling charities to use their grants in the way that helps them best.</p> <p>The third programme, Enable, is an innovative, joint grants programme with the Foundation's sole funder, Lloyds Banking Group, aimed at boosting community volunteering. Funding will be provided to charities to support projects delivered through volunteers, with Lloyds Banking Group's colleagues across Scotland volunteering their time and skills to help deliver the projects and support the charities. This programme offers a grant of £30,000 - £90,000 over three years (£10k-£30k per annum) for volunteering projects/costs/initiatives.</p> <p>Grants programmes 2024 Empower: Opens February 2024. To be eligible to apply, charities must: – Have an income of between £150k – £500k. Have a minimum of three years accounts lodged at OSCR. Charities can apply for a 3 year unrestricted grant of £150k (£50k per annum).</p> <p>Energise: Opens May 2024. To be eligible to apply, charities must: – Have an income of £150k or less. Have a minimum of one year accounts lodged at OSCR.</p>

Charities can apply for a 2 year unrestricted grant of £20k (£10k per annum).

Cash for Kids is supporting children and young people through the cost-of-living crisis, with £1.6 million available to support 32,200 children across the UK.

In response to the crisis hitting so many families right now we've launched this new fund, to provide

		<p>emergency essentials that support the physical and mental well-being of children who are struggling. These could include food, clothing and household energy costs, but we'll also consider anything that helps meet children's most basic needs.</p> <p>Grants are £50 per child per household, and we aim to get the funds to families as soon as possible.</p>
<p><u>CORRA FOUNDATION: WAY FORWARD FOR FAMILIES PARTNERSHIP</u></p>	<p>Initial enquiries invited before 19 March</p>	<p>The Way Forward for Families Partnership, a joint programme invested in by Corra Foundation and the Scottish Government, which will invite applications for funding from partnerships, led by third sector organisations working in partnership with public bodies, to deliver support to children, young people and families affected by alcohol and other drugs.</p> <p>The programme will distribute £615,000 in grants. Applicants can apply for up to £250,000 over three years and a minimum of 50% matched funding must be in place in each funding year. The Trust now focuses on one key area of funding support - offering grants to charities that support disabled people in Scotland.</p> <p>Applicant charities may assist with a wide range or specific groups of people, for example those living with mental ill health, cancer, physical and sensory impairments and long-term health conditions, as well as people with learning disabilities, autistic people, and other neurodivergent people.</p> <p>In addition, the Trust is particularly keen to receive grant applications from the following:</p> <ul style="list-style-type: none"> • smaller charities meeting a demonstrable 'need' from their local community • causes that do not have a strong public profile, including new Scottish charities • charities developing innovative approaches, including pilot projects <p>The Trust operates two rounds of grants per calendar year: a Spring/Summer round – with applications submitted between early January to late February, and taken to the Board meeting in late May/ early June; an Autumn/Winter round – with applications submitted between late June to mid-August, and taken to the Board meeting in late November/early December.</p>
