<p><a href="#"><u>COMMUNITIES MENTAL HEALTH AND WELLBEING FUND FOR ADULTS YEAR 4</u></a></p>	<p><b>25th November 2024</b></p>	<p>Voluntary Action Shetland (VAS) is delighted to launch the fourth year of the Communities Health and Wellbeing Fund for Adults on behalf of the Scottish Government on Friday 27th September 2024. The Fund was established in October 2021 and to date has distributed around £51 million to community initiatives supporting mental health and wellbeing across Scotland.</p> <p>The Fund has a strong focus on prevention and early intervention and aims to support grass roots community groups in tackling mental health inequalities and address priority issues of social isolation and loneliness, suicide prevention and tackling poverty and inequality. There will be a continued emphasis in Year 4 on responding to the ongoing cost of living crisis and on those facing socio economic disadvantage, with a particular focus on supporting the six priority family groups identified under Best Start Bright Futures: Tackling Child Poverty Delivery Plan.</p> <p>The Fund will continue to be delivered through a locally focused and co-ordinated approach via local partnership groups (building upon existing partnerships and with VAS as lead partner), working together to ensure that support to community based organisations is directed appropriately and in a coherent way. This collaborative approach is more important than ever, giving increasing budget and capacity constraints within individual sectors.</p> <p>Closing Date for applications is Mon 25th November 2024.</p> <p>A maximum of £5,000 can be applied for to support activities until 31st March 2026.</p> <p>The overarching aim of the Fund is to support community based initiatives that promote and develop good mental health and wellbeing and/or mitigate and protect against the impact of distress and mental ill health within the adult population (aged 16 or over), with a particular focus on prevention and early intervention.</p>

		<p>Specifically, it aims to:</p> <ol style="list-style-type: none"> <li>1. Tackle mental health inequalities through supporting a range of 'at risk' groups</li> <li>2. <a href="#"><u>AWARDS FOR YOUNG MUSICIANS</u></a>	<b>Anytime</b>	<p>Awards for Young Musicians supports outstanding young instrumentalists making music in any genre. If you can clearly show that you are talented and committed and that you need financial help with your music costs then you can apply for an Award of up to £2000. The average award in 2020 was £550. Young musicians aged between 5 and 17 years of age and are living and studying in the UK are eligible to apply.</p>

Energise is a multi-year grants programme supporting small and local charities that are closest to the real issues facing our communities. Available to new (and more established) charities this programme offers a two-year unrestricted grant of £20,000 (£10,000 per annum), enabling charities to use their grants in the way that helps them best.</p> <p>The third programme, Enable, is an innovative, joint grants programme with the Foundation's sole funder, Lloyds Banking Group, aimed at boosting community volunteering. Funding will be provided to charities to support projects delivered through volunteers, with Lloyds Banking Group's colleagues across Scotland volunteering their time and skills to help deliver the projects and support the charities. This programme offers a grant of £30,000 - £90,000 over three years (£10k-£30k per annum) for volunteering projects/costs/initiatives.</p> <p>Grants programmes 2024</p> <p><b>EMPOWER:</b> To be eligible to apply, charities must: –  Have an income of between £150k – £500k. Have a minimum of one year accounts lodged at OSCR. The programme provides items that meet a child’s most basic needs such as a bed to sleep in, a cooker to provide a hot meal and other items or services critical to a child’s wellbeing.</p> <p>All applications must be made by a registered referrer.</p> <p>The BBC Children in Need Emergency Essentials Programme has now reopened, operating as normal, and we aim to process applications within 10 working days. While our grants can contain funding for household items, it isn’t the main purpose of the grant.</p> <p>Applications must be made by a support worker who is working closely with the family or young person. Support workers are also responsible for spending the grant and providing receipts.</p>

<a href="#"><u>CASH FOR KIDS - COST OF LIVING GRANTS</u></a>		<p>Cash for Kids is supporting children and young people through the cost-of-living crisis, with £1.6 million available to support 32,200 children across the UK.</p> <p>In response to the crisis hitting so many families right now we've launched this new fund, to provide emergency essentials that support the physical and mental well-being of children who are struggling. These could include food, clothing and household energy costs, but we'll also consider anything that helps meet children's most basic needs.</p> <p>Grants are £50 per child per household, and we aim to get the funds to families as soon as possible.</p>
<a href="#"><u>CASH4CLUBS</u></a>	<b>12 November 2024</b>	<p>Cash4Clubs is a small grants scheme set up in 2008 to support local sports clubs. Grants of £2,000 (€2,000 in Ireland) are available this autumn for community organisations working with adults from under-represented communities, delivering sport or physical activity for social purpose.</p> <p>The 2024 programme is exclusively focused on supporting adult clubs, with an emphasis on 18–25 year olds. The funding will be unrestricted but with an outcome of increasing participation, meaning clubs are able to decide how best to use the grant to engage more adults from their local communities.</p> <p>The funding comes from gambling company Flutter UKI, and Sported, the UK's largest network of community sports groups. The unrestricted grant can be used for anything that will support your organisation to continue your activities and increase participation in your local community. Typical examples of costs might include a contribution towards:</p> <ul style="list-style-type: none"> <li>• Venue hire</li> <li>• Utilities such as heating or lighting</li> <li>• Equipment</li> <li>• Coaching costs</li> <li>• Volunteer expenses</li> <li>• Kit</li> <li>• Marketing and communications</li> <li>• Training and qualifications</li> <li>• Insurances and affiliations</li> </ul>

		<p>Not-for-profit organisations, including charities, community groups and traditional sports clubs. Applicants must be either registered charities or clubs with a structured governance and constitution.</p> <p>Groups must solely be delivering activities to adults (18+) to be eligible for funding. They will prioritise applications focused on 18-25 year olds. You cannot apply if your organisation or club runs junior activities.</p> <p>Applicants must demonstrate that they are using sport for a wider social purpose with a goal to increase participation of adults from under-represented groups. We are particularly interested in submissions from groups working in areas of high deprivation.</p>
