<a href="#"><u>CLIMATE ENGAGEMENT LAB – 2023 OPEN CALL FOR INNOVATION PARTNERSHIP</u></a>		<p>Climate Outreach is looking for a new innovation partner organisation to reach and motivate specific audiences in the UK. The <a href="#"><u>Climate Engagement Lab</u></a> is looking to support an existing project that is engaging people who are concerned about politics and climate change, but aren't generally part of the climate conversation and are deeply and instinctively distrustful that 'elites' will do much to help. <a href="#"><u>COMMUNITY RIGHT TO BUY FUND</u></a>		<p>The Community Right to Buy Fund provides financial support for community organisations in the Highlands and Islands of Scotland.</p> <p>The fund helps communities pay for professional services to help them register an interest in land or buildings under the Community Right to Buy legislation. These services could include legal title searches or help with mapping.</p> <p>This support is for community organisations in the Highlands and Islands area that wish to register an interest in property through the Community Right to Buy legislation.</p> <p>What does this cost? Funding of up to £5,000 is available, to cover up to 80% of the eligible cost. Communities must be prepared to cover the rest of the cost from other sources.</p> <p>This support is unlikely to involve state subsidy, but this will be assessed on a case by case basis.</p>

<a href="#"><u>CORRA FOUNDATION - BOOST SMALL GRANTS</u></a>		<p>Boost small grants programme is for organisations supporting children and families in their local communities. It has been created to help groups that find the increases in basic running costs (for example utilities, salaries, transport) are making their work much more challenging. The Sustainable Communities Fund, is made up of two different programmes (Community Capacity Grants Programme and Environment Grants Programme). Total investment across the two programmes could reach £750,000 over the next three years.</p> <p>The <b>Community Capacity Grants Programme</b>, open to all communities within five miles of Scotland's coastline or one of Crown Estate Scotland's four rural estates, will provide early stage financial support for community projects that will contribute to local regeneration and sustainable development. The deadline for expressions of interest is Monday 26 September.</p> <p>Crown Estate Scotland are looking for local projects with demonstrable community support that will :</p>
