The <u>Climate Engagement Lab</u> is looking to support an existing project that is engaging people who are concerned about politics and climate change, but aren't generally part of the climate conversation and are deeply and instinctively distrustful that 'elites' will do much to help. <p><u>COMMUNITY RIGHT TO BUY FUND</u></p>		<p>The Community Right to Buy Fund provides financial support for community organisations in the Highlands and Islands of Scotland.</p> <p>The fund helps communities pay for professional services to help them register an interest in land or buildings under the Community Right to Buy legislation. These services could include legal title searches or help with mapping.</p> <p>This support is for community organisations in the Highlands and Islands area that wish to register an interest in property through the Community Right to Buy legislation.</p> <p>What does this cost? Funding of up to £5,000 is available, to cover up to 80% of the eligible cost. Communities must be prepared to cover the rest of the cost from other sources.</p> <p>This support is unlikely to involve state subsidy, but this will be assessed on a case by case basis.</p>

It can help them expand the range of devices and connectivity that they have available, extend the number of devices available for loan or replace devices that are coming to the end of their lives.</p>
<p><u>CONNECTING SCOTLAND - SUPPORT FOR HOUSING PROVIDERS</u></p>	<p>extended to 27 November 2023</p>	<p>Connecting Scotland is a collaboration between Scottish Government and SCVO to increase digital inclusion. The objective of this project is to provide devices and/or connectivity to organisations across Scotland providing social housing or transitional accommodation.</p> <p>There are three opportunities within this fund for devices and/or connectivity to support people who are experiencing digital exclusion:</p> <ul style="list-style-type: none"> • To form a new lending library • To be part of a community space where devices and connectivity are available • A larger improvement project for connectivity infrastructure in communal areas <p>This project is for social housing providers and voluntary and public sector organisations providing short- or longer-term transitional housing services. They are looking to fund organisations who are less experienced in digital inclusion work but who have the resource and supporting infrastructure in place to manage new projects.</p> <p>Assessment of applications will be done on a rolling basis with awards made until funds are exhausted.</p>
<p><u>CORRA FOUNDATION - BOOST SMALL GRANTS</u></p>		<p>Boost small grants programme is for organisations supporting children and families in their local communities. It has been created to help groups that find the increases in basic running costs (for example utilities, salaries, transport) are making their work much more challenging. <u>CREATIVE SCOTLAND - MADE IN SCOTLAND SHOWCASE</u>	12 noon on 22 November 2023 for decisions mid-February 2024	<p>The purpose of the Made in Scotland Programme is to raise the international profile of Scottish artists through the promotion of Scottish work at the Edinburgh Festival Fringe.</p> <p>Funding is available to help support the presentation at the Fringe of new or existing artistically ambitious work with strong onward potential as part of the Made in Scotland Showcase. All applicants should be considering their international ambitions for the show being presented. Applications can come from individual artists, companies, organisations, promoters, record labels and venues.</p> <p>All applicants must be based in Scotland. Student and non-professional companies are not eligible to apply. Those selected to be part of Made in Scotland will also receive support and advice to help them prepare for participation in the programme, including advice on marketing, venues, networking and much more.</p>

<u>CREATIVE SCOTLAND: OPEN FUND: SUSTAINING</u>	The fund is open all year round – with no deadlines	<p>Grants up to £100,000 over one year are available for charities, organisations and groups involved in the arts, screen and creative industries to adapt, respond and sustain practice.</p> <p>The fund will continue to support organisations to deliver a wide range of creative activity.</p>

Total investment across the two programmes could reach £750,000 over the next three years.</p> <p>The Environment Grants Programme, available to Crown Estate Scotland tenants, will provide grants of between £5,000 and £20,000 for projects which can deliver demonstrable environmental benefits within 18 months of award. A total of £100,000 will be made available for this programme in the first year. Typical projects could include initiatives to increase local biodiversity and activities to reduce flood risk, pollution or carbon emissions. <u>CYCLING TOURISM FACILITIES FUND (HIGHLANDS AND ISLANDS ENTERPRISE) MOVE YOUR CYCLING FACILITIES UP A GEAR</u>		<p>This fund is for businesses and community enterprises operating in the tourism sector to develop and enhance their cycle tourism facilities.
