		access to natural spaces and nature-based activities, be involved in the development and running of nature-based activities in their local area and to experience measurable positive changes to their mental health. It can provide additional support for those who need it to access other services, for example, advice or specialist mental health services. In 2021 the Trust converted to become a Scottish Charitable Incorporated Organisation (SCIO). The Trust now focuses on one key area of funding support - offering grants to charities that support disabled people in Scotland.</p> <p>Applicant charities may assist with a wide range or specific groups of people, for example those living with mental ill health, cancer, physical and sensory impairments and long-term health conditions, as well as people with learning disabilities, autistic people, and other neurodivergent people.</p> <p>In addition, the Trust is particularly keen to receive grant applications from the following:</p> <ul style="list-style-type: none"> <li>• smaller charities meeting a demonstrable 'need' from their local community</li> <li>• causes that do not have a strong public profile, including new Scottish charities</li> <li>• charities developing innovative approaches, including pilot projects</li> </ul> <p>The Trust operates two rounds of grants per calendar year:  a Spring/Summer round – with applications submitted between early <b>January to late February</b>, and taken to the Board meeting in late May/ early June; an Autumn/Winter round – with applications submitted between late <b>June to mid-August</b>, and taken to the Board meeting in late November/early December.</p>

<a href="#"><u>AWARDS FOR YOUNG MUSICIANS</u></a>	<b>Anytime</b>	Awards for Young Musicians supports outstanding young instrumentalists making music in any genre. If you can clearly show that you are talented and committed and that you need financial help with your music costs then you can apply for an Award of up to £2000. The average award in 2020 was £550. Young musicians aged between 5 and 17 years of age and are living and studying in the UK are eligible to apply.

<a href="#"><u>BANK OF SCOTLAND FOUNDATION</u></a>		<p>Bank of Scotland Foundation, has announced the launch of its new five-year strategy - "Building a Brighter Future for Scotland." The strategy aims to fund, support and champion small and local charities that work towards improving the quality of life for some of Scotland's most vulnerable people.</p> <p>The first multi-year programme under the new strategy, Empower, will launch in early February, offering real security and certainty for charities. This programme will offer a three-year unrestricted grant of £150,000 (£50,000 per annum) and collaborating with Lloyds Banking Group, the Foundation also aims to identify opportunities to add strategic value for funded charities and help them grow stronger and thrive beyond the lifetime of their grant.</p> <p>Two further multi-year programmes will be launched later in the year. Energise is a multi-year grants programme supporting small and local charities that are closest to the real issues facing our communities. Available to new (and more established) charities this programme offers a two-year unrestricted grant of £20,000 (£10,000 per annum), enabling charities to use their grants in the way that helps them best.</p> <p>The third programme, Enable, is an innovative, joint grants programme with the Foundation’s sole funder, Lloyds Banking Group, aimed at boosting community volunteering. Funding will be provided to charities to support projects delivered through volunteers, with Lloyds Banking Group’s colleagues across Scotland volunteering their time and skills to help deliver the projects and support the charities. The fund aims to support community organisations to reduce their building energy costs and carbon emissions. The <a href="#"><u>Let's Do Net Zero Community Buildings Fund</u></a> is open now and is planned to run until the end of March 2025, subject to funding availability. Funding is available for many types of community building, including: community cafes, community hubs, faith buildings, public halls, community halls and centres. Grant funding is available for up to 80% of eligible costs up to a maximum of £80,000. New guidance now available.
<a href="#"><u>CASH FOR KIDS - COST OF LIVING GRANTS</u></a>		<p>Cash for Kids is supporting children and young people through the cost-of-living crisis, with £1.6 million available to support 32,200 children across the UK.</p> <p>In response to the crisis hitting so many families right now we've launched this new fund, to provide emergency essentials that support the physical and mental well-being of children who are struggling. These could include food, clothing and household energy costs, but we'll also consider anything that helps meet children's most basic needs.</p> <p>Grants are £50 per child per household, and we aim to get the funds to families as soon as possible.</p>

The <a href="#"><u>Climate Engagement Lab</u></a> is looking to support an existing project that is engaging people who are concerned about politics and climate change, but aren't generally part of the climate conversation and are deeply and instinctively distrustful that 'elites' will do much to help. Through the partnership, they will provide free support for a group that's engaging working class communities on climate or climate-adjacent (i.e. transport, energy, food) projects.  The chosen partner will get support to apply evidence-backed insights to their project, along with up to £3,000 to cover the costs of participation.
<a href="#"><u>COMMUNITY RIGHT TO BUY FUND</u></a>		The Community Right to Buy Fund provides financial support for community organisations in the Highlands and Islands of Scotland. The fund helps communities pay for professional services to help them register an interest in land or buildings under the Community Right to Buy legislation. These services could include legal title searches or help with mapping. Funding of up to £5,000 is available, to cover up to 80% of the eligible cost. Communities must be prepared to cover the rest of the cost from other sources. This support is unlikely to involve state subsidy, but this will be assessed on a case by case basis.
