<u>KING CHARLES III CHARITABLE FUND - SMALL GRANTS</u>	Opens January 2024	<p>This new programme focuses on supporting projects that contribute to the environment, countryside, social inclusion, health and wellbeing, education, heritage and conservation.</p> <p>Each year, the fund will allocate grants of up to £5,000 to about 100 community-based organisations, those with an annual income of less than £1 million and two years of activity.</p>
<u>NATIONAL LOTTERY COMMUNITY FUND AWARDS FOR ALL PROGRAMME</u>		<p>National Lottery Community Fund Awards for All programme has increased the maximum grant amount for community-led projects to £20,000 over two years.</p> <p>Awards For All supports projects that aim to help improve local communities and the lives of people most in need. Priorities are: bringing communities together, improving places that matter to communities, enabling people to fulfil their potential and supporting people, communities and organisations facing more demand due to cost of living crisis.</p> <p>Funding for Community led projects: Awards for All can provide between £300 and £20,000 and can support projects for up to two years.</p> <p>Funding for arts and sports projects: Awards for All can provide between £300 and £10,000 and can support projects for up to 12 months.</p>
<u>SCREWFIX FOUNDATION (UK)</u>		<p>Offer grants of up to £5,000 to support UK registered charities and not-for-profit organisations, projects, that will improve community facilities used by those in need throughout the UK. <u>SOCIAL HOUSING NET ZERO HEAT FUND</u>		This Scottish Government fund will help social housing landlords across Scotland install zero emission heating systems and energy efficiency measures. The funding can be used for the retrofit or refurbishment of existing housing and is not for new build social housing.
<u>THE LINTEL TRUST SMALL GRANT PROGRAMME</u>	20 Dec	<p>The Lintel Trust provides support for projects helping people to maintain their tenancies, improve their lives and participate fully in community life. Most projects funded offer support to those who are excluded from community activities.</p> <p>The Trust's small grant giving programme targets small housing related community projects based in Scotland that have a close connection with a housing association, housing co-operative or other social housing provider such as a local authority. Small grants make up more than 30% of the total project cost. The small grant programme makes grant awards of either £500 or £1,000 to community led grassroots projects with a close link to social housing providers in recognition of the huge differences being made by small community based initiatives. Grants should be used within a 12 month period from the date of the award.</p>

<u>BUSINESS CHARGEPOINT FUNDING</u>		To support the use of electric vehicles across Scotland, Transport Scotland offers grant funding to help organisations install electric vehicle (EV) charging infrastructure on their premises. The funding is distributed by Energy Saving Trust and is currently available for chargepoints that will only be used by occupiers, staff and visitors.
<u>BUSINESS ENERGY SCOTLAND: SME LOAN SCHEME</u>		Cashback grants of £20,000 and interest free loans up to £100,000 are available to charities, community organisations and social enterprises to install energy efficient systems, equipment or to upgrade building fabric such as energy efficient lighting. Free assessments are available.
<u>CANOE FOUNDATION</u>	31 January 2024	<p>The Foundation supports projects that increase access to canoeing. The fund aims to support community organisations to reduce their building energy costs and carbon emissions. The <u>Let's Do Net Zero Community Buildings Fund</u> is open now and is planned to run until the end of March 2025, subject to funding availability. Funding is available for many types of community building, including: community cafes, community hubs, faith buildings, public halls, community halls and centres. Grant funding is available for up to 80% of eligible costs up to a maximum of £80,000. New guidance now available.

<u>CHARLES HAYWARD FOUNDATION - OLDER PEOPLE - SMALL GRANTS</u>	n/a	Funds preventative and early intervention programmes being delivered at the community level which allow older people to stay in their own homes and remain independent. They are particularly interested in programmes which show some creativity in improving the quality of life of older people. Up to £7,000.
<u>CIRCULAR ECONOMY INVESTMENT FUND</u>	N/A	This fund, administered by Zero Waste Scotland, offers investment to SMEs based in Scotland for work that will help to deliver circular economy growth.
<u>CIRCULAR TEXTILES FUND</u>		This fund supports the development of circular supply chains across the textiles industry in Scotland to help businesses achieve net zero carbon emissions. Zero Waste Scotland is administering the fund, which is backed by the Scottish Government, to help reduce the environmental impact of textiles.
<u>CLIMATE ENGAGEMENT LAB – 2023 OPEN CALL FOR INNOVATION PARTNERSHIP</u>		Climate Outreach is looking for a new innovation partner organisation to reach and motivate specific audiences in the UK. The <u>Climate Engagement Lab</u> is looking to support an existing project that is engaging people who are concerned about politics and climate change, but aren't generally part of the climate conversation and are deeply and instinctively distrustful that 'elites' will do much to help. Through the partnership, they will provide free support for a group that's engaging working class communities on climate or climate-adjacent (i.e. transport, energy, food) projects. The chosen partner will get support to apply evidence-backed insights to their project, along with up to £3,000 to cover the costs of participation.
<u>COMMUNITY RIGHT TO BUY FUND</u>		The Community Right to Buy Fund provides financial support for community organisations in the Highlands and Islands of Scotland. The fund helps communities pay for professional services to help them register an interest in land or buildings under the Community Right to Buy legislation. These services could include legal title searches or help with mapping. Funding of up to £5,000 is available, to cover up to 80% of the eligible cost. Communities must be prepared to cover the rest of the cost from other sources. This support is unlikely to involve state subsidy, but this will be assessed on a case by case basis.
<u>CORRA FOUNDATION - BOOST SMALL GRANTS</u>		Boost small grants programme is for organisations supporting children and families in their local communities. It has been created to help groups that find the increases in basic running costs (for example utilities, salaries, transport) are making their work much more challenging. Boost will provide grants of £500-£3,000 to grassroots organisations and charities with a yearly income of up to £50,000 whose work benefits children and families.

		This fund aims to ensure accessible, supportive community-led activities remain available to children and families despite the challenges the cost of living poses for charities and community groups. Boost is delivered by Corra Foundation and is a partnership between the STV Children's Appeal and Corra Foundation.
<u>CREATIVE SCOTLAND - MADE IN SCOTLAND ONWARD INTERNATIONAL TOURING FUND</u>	Remains open until it is fully allocated	The aim of the Onward International Touring Fund is to enable artists, bands and ensembles based in Scotland to take up new international touring opportunities for work programmed as a direct result of the inviting promoter seeing the work at the Edinburgh Festival Fringe. This fund exists to support costs linked to flights, freight, visas and the translation of marketing materials. Other costs are expected to be met by the inviting promoter.
<u>CREATIVE SCOTLAND: FUTURE FUNDING FRAMEWORK</u>		If you are a voluntary organisation delivering arts, creative and cultural activities, check the updated planning timetable for multi-year funding published this week by Creative Scotland. Their Open Fund also relaunches in October. Information sessions to follow.
<u>CREATIVE SCOTLAND: OPEN FUND: SUSTAINING CREATIVE DEVELOPMENT</u>	The fund is open all year round – with no deadlines	<p>Grants up to £100,000 over one year are available for charities, organisations and groups involved in the arts, screen and creative industries to adapt, respond and sustain practice.</p> <p>The fund will continue to support organisations to deliver a wide range of creative activity. This includes funding for:</p> <ul style="list-style-type: none"> • a specific one-off project or production or • a period of creative research and development or • a longer term programme of work. <p>It can also support organisations to undertake business and organisational development that will:</p> <ul style="list-style-type: none"> • enhance their business sustainability through the development of new or more diverse income streams or • consider broader organisational development costs. <p>Eligible organisations can apply for funding between £1k and £100k for projects or programmes lasting up to 18 months. If you are seeking more than £100k and 18 months support refer to the <u>National Lottery Extended Programme Fund</u> (deadline: 14 November 2023).</p>
<u>CULTURE & BUSINESS FUND SCOTLAND (C&BS FUND)</u>	Opens 24 May	The C&BS Fund provides match funding to culture organisations to enable partnerships and collaborations with businesses by incentivising sponsorships to bring diverse creative projects to life.

		Through ongoing support from Scottish Government, in 2023, the C&BS Fund will provide match funding of up to 14,000 pounds per organisation, with the intention to support as many arts and heritage organisations as possible, from grassroots initiatives to established cultural events. Other priorities for the C&BS Fund this year will be to support organisations who have implemented Fair Work policies, have introduced carbon neutral plans or policies and have embedded equality, diversity and inclusion in all aspects of the activities for which they seek funding through the C&BS Fund
<u>CYCLING SCOTLAND: CYCLING FRIENDLY GRANTS</u>		Grants up to £20,000 are available for community groups and voluntary organisations for local projects that will improve cycling facilities and increase the number of people cycling. Other funding programmes are available.
<u>CYCLING TOURISM FACILITIES FUND (HIGHLANDS AND ISLANDS ENTERPRISE) MOVE YOUR CYCLING FACILITIES UP A GEAR</u>		<p>This fund is for businesses and community enterprises operating in the tourism sector to develop and enhance their cycle tourism facilities. The minimum grant is £5,000 up to a maximum of £25,000 for capital expenditure, which will cover up to 50% of total eligible project costs.</p> <p>Funding can be used towards a variety of capital projects including investing in fixtures, fittings, construction, adaptation, or upgrade of premises to improve cycling tourism facilities.
