The funding aims to reduce homelessness, enable young people to access support and encourage their meaningful involvement in project development.
<a href="#"><u>CORRA FOUNDATION – BOOST FUND</u></a>	Opens 30 April 2024	<p>On 30th April, the Boost Fund will open to applications from community groups supporting children and families affected by poverty in Scotland. Grants of up to £3000 are available to constituted groups and charities with an annual income of less than £50,000. This year, it's also open to unconstituted groups who can apply for a grant of between £250-£1500.</p> <p>Boost is designed to work for communities with a short application form, quick turnaround time on decision, and light touch reporting for grant holders.</p>
<a href="#"><u>ESSENTIA FOUNDATION</u></a>	<p>Opens: 13 May 2024</p> <p>Deadline: 24th June 2024</p>	The Essentia Foundation is looking to provide financial support to charities and community groups that will help achieve the following objectives: - Improved health and social welfare of children and young people up to the age of 25 years old. - Increased opportunities for training, enhancing learning, upskilling, and developing career opportunities, and supporting young people up to the age of 25 years old to move towards employment This round of funding is aimed at supporting grassroots community organisations across Scotland.
<a href="#"><u>GIVESTAR ADVENTURE FOR GOOD GRANTS</u></a>	31 May	This fund offers a unique opportunity, supporting individuals (aged 18 or over) embark on an adventure to raise funds for charity. Individuals can apply for a share of £20,000 in funding to help them cover any costs associated with the challenge, such as: buying specialist gear, paying for flights, accommodation, and camera equipment.

And we want to inspire bold and exciting change.</p> <p>From Wednesday 27 March 2024 you can apply for funding from the Climate Action Fund to help do this.</p> <p>We'll fund projects that reach more people by either:</p> <ul style="list-style-type: none"> <li>• linking climate action to the everyday lives and interests of local communities. And inspiring them to take action.</li> <li>• influencing communities at a regional or national level. Like linking up groups across locations. Or a campaign that inspires change across one country, or the whole UK.</li> </ul> <p>You should be in a partnership with</p> <ul style="list-style-type: none"> <li>• a mix of organisations and sectors</li> <li>• smaller groups that represent the people you're working with.</li> </ul> <p>You do not have to be a climate or environment-focused organisation to apply</p> <p>We want to reach people who are new to climate action by funding other types of organisations too. <a href="#"><u>NATIONAL LOTTERY OPEN FUND FOR ORGANISATIONS</u></a>	<b>No deadlines</b>	<p>The National Lottery Open Fund for Organisations is an update of the Open Fund: Sustaining Creative Development Fund which Creative Scotland administered between 2020 and early 2023.</p>

<p><b>AN UPDATE OF THE OPEN FUND: SUSTAINING CREATIVE DEVELOPMENT FUND</b></p>		<p>The fund aims to continue to support organisations who seek funding to undertake creative activity such as a specific project or production, a programme of creative work, or a period of research and development. Any type of constituted artistic, creative or cultural organisation based in Scotland can apply.</p> <p>Eligible organisations can apply for funding between £1k and £100k for projects or programmes lasting up to 18 months.</p>
<p><a href="#"><u>SCOTTISH GOVERNMENT - THE CLIMATE ENGAGEMENT FUND</u></a></p>	<p><b>23.59 on 7 May 2024</b></p>	<p>The Climate Engagement Fund aims to build understanding of the climate emergency across communities in Scotland, both geographic and communities of interest, by offering support for climate engagement activities.</p> <p>The CEF can be used to engage people and deepen their understanding of the climate emergency and the action that society needs to take to reach net zero, thus delivering on the ‘understand’ objective of the Public Engagement Strategy for Climate Change.</p> <p>Examples of activities that can be funded include:</p> <ul style="list-style-type: none"> <li>• public events/lectures</li> <li>• climate festivals</li> <li>• climate conversations</li> <li>• learning and development (e.g. carbon/climate training, climate coaching)</li> <li>• skills workshops</li> <li>• exhibitions/art installations</li> <li>• participatory arts</li> <li>• youth development programmes</li> <li>• staff costs linked to delivery of the project</li> </ul> <p>Eligible applicant organisations must be ‘trusted messengers’. <p><a href="#"><u>SCREWFIX FOUNDATION (UK)</u></a></p>	<p><b>Quarterly Applications Next Deadline - Friday 10 May</b></p>	<p>Offer grants of up to £5,000 to support UK registered charities and not-for-profit organisations, projects that will improve community facilities used by those in need throughout the UK. Before applying, your organisation must:</p> <ul style="list-style-type: none"> <li>• Be a registered charity or not for profit organisation.</li> <li>• Help those in need. This could be by reason of financial hardship, sickness, distress or other disadvantages in the UK.</li> </ul>

<a href="#"><u>THE BIG GIVE - CHRISTMAS CHALLENGE</u></a>	<b>Opens: 13 May Closes: 5 June 2024.</b>	<p>The Christmas Challenge is an online match funding campaign that can help your charity to raise more money this Christmas. It offers supporters of participating charities the opportunity to have their donations doubled when the campaign goes live from late November - early December.</p> <p>The campaign will run from 3 - 10 December 2024.</p>
<a href="#"><u>THE PAUL HAMLYN FOUNDATION MIGRATION FUND</u></a>	<b>No deadlines</b>	<p>The Paul Hamlyn Foundation's Migration Fund is currently open for applications. Through the Migration Fund, the Foundation wants to support organisations who are working towards helping migrants and diaspora communities, building solidarity and collaboration across communities, and challenging the harm, inequity and oppression within their organisational structures and work. The fund is open to applications from non-profit organisations across the UK. Newly established and unincorporated groups are also welcome to apply if they fit the criteria.</p> <p>The Foundation can also provide pre-application support and a bursary of up to £500 to apply.</p>
<a href="#"><u>THE STEEL CHARITABLE TRUST</u></a>	<b>11 July</b>	<p>A charitable grant-giving trust that makes awards to registered charities throughout the UK within the categories of Arts and Heritage, Education, Environment, Health, and Social or Economic Disadvantage.</p> <p>Applications are taken all year for the Trust's rolling grants programme and Trustees meet quarterly to assess applications and make awards.</p>
<a href="#"><u>THE TRIANGLE TRUST 1949 FUND - YOUNG WOMEN AND GIRLS</u></a>	<b>Round 1: Closes 23 May 2024 Round 2: Open on 18 September 2024 and closes 30 October 2024</b>	<p>The Triangle Trust 1949 run two grant rounds each year. The current round of funding is aimed at projects that are focused on young women and girls who already have a history of offending or who are at high risk of registering a first offence. They are looking to support work that specifically aims to reduce the likelihood of a young woman or girl either entering the criminal justice system or reoffending and support them to move on positively with their lives.</p> <p>They will fund work taking place with young women and girls aged between 11 and 30 and will only consider applications from organisations that exist solely to support the wellbeing and welfare of women and girls. Funding can only be used to work with young women and girls who have been in the criminal justice system or who are at a high risk of entering it, even if your organisation works with vulnerable young women and girls more broadly. There is a two-stage application process involving an online application followed by an assessment visit.</p>

<p><u><a href="#">VOLUNTARY THROUGH-CARE GRANT FUND</a></u></p>	<p>5.00pm on Monday 10th June 2024</p>	<p><b>COMMISSIONING OPPORTUNITY</b></p> <p>Community Justice Scotland (CJS) has been conducting a review into the current operation and demand for voluntary throughcare services and in September 2023 provided the options and our recommendation to Scottish Ministers as to the scale and type of such services that the Scottish Government should grant fund in the future.</p> <p>The purpose of the grant fund is to establish a national partnership of voluntary sector organisations to provide throughcare support to people leaving prison after a prison sentence of less than four years or those leaving prison after a period of time spent on remand. The partnership will offer needs lead and person centred support to people leaving prison, and will provide an initial offer of resettlement support upon release from prison with the option of providing more intensive support to those who need it for up to 12 months. <a href="#"><u>7STARS FOUNDATION</u></a>	<b>30th April 2024</b>	<p>Offers grants of up to £2,500 to support challenged and vulnerable young people under the age of 16. Registered UK charities working in areas of deprivation and disadvantage with an annual turnover of less than £1.5 million are eligible to apply. Projects should aim to empower young people, provide immediate support, and address gaps in existing services by for example providing recreational activities, mentoring programs, and counselling sessions.</p> <p>There are two additional funding streams:</p> <ul style="list-style-type: none"> <li>• Shine Bright Grants: Up to £1,500 to purchase educational, wellbeing, or recreational items for young people under 16.</li> <li>• Individual Funding: Up to £500 for young people who are represented by a safeguarding, legal, social, or outreach professional.</li> </ul>
<a href="#"><u>AGNES HUNTER SCIO</u></a>	<b>Next Deadline Aug 2024</b>	<p>The Agnes Hunter Trust SCIO was established in 1954 to support registered charities delivering health and social welfare projects in Scotland. In 2021 the Trust converted to become a Scottish Charitable Incorporated Organisation (SCIO). The Trust now focuses on one key area of funding support - offering grants to charities that support disabled people in Scotland.</p> <p>Applicant charities may assist with a wide range or specific groups of people, for example those living with mental ill health, cancer, physical and sensory impairments and long-term health conditions, as well as people with learning disabilities, autistic people, and other neurodivergent people.</p> <p>In addition, the Trust is particularly keen to receive grant applications from the following:</p> <ul style="list-style-type: none"> <li>• smaller charities meeting a demonstrable 'need' from their local community</li> <li>• causes that do not have a strong public profile, including new Scottish charities</li> <li>• charities developing innovative approaches, including pilot projects</li> </ul> <p>The Trust operates two rounds of grants per calendar year:  a Spring/Summer round – with applications submitted between early <b>January to late February</b>, and taken to the Board meeting in late May/ early June; an Autumn/Winter round – with applications submitted between late <b>June to mid-August</b>, and taken to the Board meeting in late November/early December.</p>

<a href="#"><u>ALLANDER YOUTH ACTIVITIES TRUST</u></a>	Ongoing	You will be a Scout Group, a section of a Scout Group or the equivalent in a voluntary organisation that directly seeks to improve the welfare of young people through the provision of training and/or education. You may be a local group or part of a National Organisation but not a Scout District, Scout Region or equivalent in other similar organisations. Or you will be an individual member of such an organisation wishing to take part in an activity that will develop you and as a result of which you gain new skills that you will then use for the benefit of young people within your organisation.
<a href="#"><u>AMERICAN EXPRESS – COMMUNITY GIVING PROGRAMME</u></a>	Ongoing	Grants are available for not-for-profit organisations to help empower more diverse and inclusive workforces and communities, build inclusive economic growth and financial literacy, and advance climate innovation and action.
<a href="#"><u>ARCHITECTURAL HERITAGE FUND: PROJECT VIABILITY GRANT</u></a>	Ongoing	Grants up to £10,000 are available for constituted community groups and social enterprises to explore the viability or development costs associated with the regeneration of historic buildings.
<a href="#"><u>ARNOLD CLARK COMMUNITY FUND</u></a>	n/a	Open to community groups and UK charities. Up to £1,000 is available to organisations that can provide immediate help to their local communities
<a href="#"><u>AUSTIN AND HOPE PILKINGTON TRUST</u></a>	28 Feb 2024 20 April 2024 31 July 2024 30 Sept 2024	<p>The Trust gives grants to registered charities that work in the UK. They focus on specific priorities every year. In rounds 1 and 2 they will consider applications that focus on projects that support and improve employment and training for disabled people. In rounds 3 and 4 they will consider applications that focus on: providing nutritious meals, food education, cooking skills, eliminating food waste.</p> <p>They only award grants to organisations registered with the Charity Commission or OSCR, or exempt from registration.</p> <p>They have four grant rounds per year. The dates for these are:</p> <ul style="list-style-type: none"> <li>• Grant Round 1: 1 - 28 February</li> <li>• Grant Round 2: 1 - 30 April</li> <li>• Grant Round 3: 1 - 31 July</li> <li>• Grant Round 4: 1 - 30 September</li> </ul> <p>Please apply only if your charity meets the relevant income and expenditure criteria. This changes each round so check the website guidelines before applying.</p>






<a href="#"><u>AVIVA COMMUNITY FUND – CROWDFUNDING REQUIRED</u></a>	<b>Ongoing</b>	Grants up to £50,000 are available for not-for-profit organisations in the UK who can raise their initial funding through a crowdfunding campaign for projects that address Aviva’s current themes of climate champions and financial empowerment.
<a href="#"><u>AWARDS FOR YOUNG MUSICIANS</u></a>	<b>Anytime</b>	Awards for Young Musicians supports outstanding young instrumentalists making music in any genre. If you can clearly show that you are talented and committed and that you need financial help with your music costs then you can apply for an Award of up to £2000. The average award in 2020 was £550. Young musicians aged between 5 and 17 years of age and are living and studying in the UK are eligible to apply.
<a href="#"><u>BAILLIE GIFFORD COMMUNITY AWARDS</u></a>	<b>Ongoing</b>	The fund aims to support local grassroots organisations working to address food insecurity and social isolation
<a href="#"><u>BANK OF SCOTLAND FOUNDATION</u></a>		<p>Bank of Scotland Foundation, has announced the launch of its new five-year strategy - "Building a Brighter Future for Scotland." The strategy aims to fund, support and champion small and local charities that work towards improving the quality of life for some of Scotland's most vulnerable people.</p> <p>The first multi-year programme under the new strategy, Empower, will launch in early February, offering real security and certainty for charities. This programme will offer a three-year unrestricted grant of £150,000 (£50,000 per annum) and collaborating with Lloyds Banking Group, the Foundation also aims to identify opportunities to add strategic value for funded charities and help them grow stronger and thrive beyond the lifetime of their grant.</p> <p>Two further multi-year programmes will be launched later in the year. Energise is a multi-year grants programme supporting small and local charities that are closest to the real issues facing our communities. Available to new (and more established) charities this programme offers a two-year unrestricted grant of £20,000 (£10,000 per annum), enabling charities to use their grants in the way that helps them best.</p> <p>The third programme, Enable, is an innovative, joint grants programme with the Foundation’s sole funder, Lloyds Banking Group, aimed at boosting community volunteering. Funding will be provided to charities to support projects delivered through volunteers, with Lloyds Banking Group’s colleagues across Scotland volunteering their time and skills to help deliver the projects and support the charities. This programme offers a grant of £30,000 - £90,000 over three years (£10k-£30k per annum) for volunteering projects/costs/initiatives.</p> <p>Grants programmes 2024  <a href="#"><u>Empower</u></a>: Opens February 2024.</p>

To be eligible to apply, charities must: –  
 Have an income of between £150k – £500k.  
 Have a minimum of three years accounts lodged at OSCR.

<a href="#"><u><b>BENEFACT GROUP - MOVEMENT FOR GOOD – NOMINATE A CHARITY AWARDS</b></u></a>	<b>Check website for deadlines</b>	<p>Movement for Good is our annual programme of giving that anyone can get involved in, and again this year we'll be donating over £1 million to charities and good causes nominated by you.</p> <p><a href="#"><u>Nominate a charity for £1,000</u></a></p> <p>Nominations made from Jan 1st 2024 – December 19th 2024 will be entered into all remaining £1,000 draws. Nominations from previous years do not roll over.</p>
<a href="#"><u><b>BENEFACT TRUST</b></u></a>		<p>Funding is now available under the following grants programmes:</p> <p><a href="#"><u>Community Impact Grants</u></a> A programme of funding aimed at supporting projects that directly address the social challenges faced by some of the most vulnerable communities in our society.</p> <p><a href="#"><u>Building Improvement Grants</u></a> For the essential repair and improvement of churches and Christian buildings.</p> <p><a href="#"><u>Heritage Skills for Christian Buildings Grants</u></a> Focused on the preservation of essential heritage skills and careers through apprenticeships, scholarships, and training courses.</p> <p><a href="#"><u>Methodist Grants</u></a> For building projects that support Methodist churches in their mission and ministry, with a particular focus on church growth, community engagement and accessibility.</p> <p><a href="#"><u>Roof Alarm Grants</u></a> To protect churches from metal theft.</p>
<a href="#"><u><b>BUSINESS CHARGEPOINT FUNDING</b></u></a>		To support the use of electric vehicles across Scotland, Transport Scotland offers grant funding to help organisations install electric vehicle (EV) charging infrastructure on their premises. The funding is distributed by Energy Saving Trust and is currently available for chargepoints that will only be used by occupiers, staff and visitors.

<a href="#"><u><b>BUSINESS ENERGY SCOTLAND: SME LOAN SCHEME</b></u></a>		Cashback grants of £20,000 and interest free loans up to £100,000 are available to charities, community organisations and social enterprises to install energy efficient systems, equipment or to upgrade building fabric such as energy efficient lighting. Free assessments are available.
<a href="#"><u><b>CARES LET'S DO NET ZERO COMMUNITY BUILDINGS FUND</b></u></a>	<b>See guidance</b>	Funding is now available from the Scottish Government's Community and Renewable Energy Scheme (CARES). The fund aims to support community organisations to reduce their building energy costs and carbon emissions. The <a href="#"><u>Let's Do Net Zero Community Buildings Fund</u></a> is open now and is planned to run until the end of March 2025, subject to funding availability. Funding is available for many types of community building, including: community cafes, community hubs, faith buildings, public halls, community halls and centres. Grant funding is available for up to 80% of eligible costs up to a maximum of £80,000. New guidance now available.
<a href="#"><u><b>CASH FOR KIDS - COST OF LIVING GRANTS</b></u></a>		<p>Cash for Kids is supporting children and young people through the cost-of-living crisis, with £1.6 million available to support 32,200 children across the UK.</p> <p>In response to the crisis hitting so many families right now we've launched this new fund, to provide emergency essentials that support the physical and mental well-being of children who are struggling. These could include food, clothing and household energy costs, but we'll also consider anything that helps meet children's most basic needs.</p> <p>Grants are £50 per child per household, and we aim to get the funds to families as soon as possible.</p>
<a href="#"><u><b>CHANGES TO THE ROBERTSON TRUST FUNDING</b></u></a>		Later this year, The Robertson Trust will be making changes to the structure of their funding programmes. As a result, they will be closing to new applications from 12 noon on 31 May 2024 and will reopen with updated criteria in September 2024. Changes include increased levels of potential funding through Wee Grants and Small Grants, as well as changes to the income thresholds across all programmes.
