<a href="#"><u>GREENE KING IPA - PROUD TO PITCH IN</u></a>	1st November	<p>The aim of this fund is to support sports focussed projects that positively impact their club and/or the local community and would tangibly benefit from funding. The fund is particularly focussed on sports projects that have a long-term impact.</p>
<a href="#"><u>HENRY DUNCAN GRANTS</u></a>	30 October 2024	<p>In 2024, Henry Duncan Grants will fund women-led organisations that support women and girls within their local communities.</p> <p>Henry Duncan Grants are open to charities and registered not-for-profit organisations with an annual income of £250,000 or less. Organisations can apply for up to £40,000 across five years (£8,000 per year) in funding. In 2024, 50% of the fund is committed to women-led Black, Asian and Minority Ethnic Organisations.</p> <p>There are two types of Henry Duncan Grants in 2024:</p> <ul style="list-style-type: none"> <li>Grants for Women Led Organisations Unrestricted funding for organisations led by women. The organisation's work needs to have a focus on supporting women and girls (aged 12+) who have experienced gender-based violence. This could include working in prevention of gender-based violence, supporting women and girls currently</li> </ul>

		<p>experiencing gender-based violence, or working with survivors.</p> <ul style="list-style-type: none"> <li>Grants for Women Led, Black, Asian and Minority Ethnic Organisations Unrestricted funding for organisations that are led by Black, Asian and Minority Ethnic women and are working on issues that impact women and girls (aged 12+) in their communities. It supports the development and delivery of heritage focused schemes within conservation areas, or alternatively distinctive heritage areas with local authority recognition.</p> <p>Community participation is be integral to the design and delivery of the successful schemes your objectives should fit within the local authority’s strategic framework for Place and Regeneration.</p> <p>To qualify for the H&amp;PP, you will also need to demonstrate that your scheme meets the following criteria:</p> <ul style="list-style-type: none"> <li>It will take place within a defined area of the historic environment with heritage significance which has local authority recognition</li> </ul>

<p><b><u>SSEN TRANSMISSION - COMMUNITY BENEFIT FUND</u></b></p>	<p>Friday 22 November</p>	<p>SSEN Transmission has launched its first ever Community Benefit Fund, allowing organisations across the north of Scotland to apply for a share of £2 million for projects that will aid skills development, support the culture of local communities, and help alleviate fuel poverty. The fund marks the beginning of what could be over £100 million in support for communities in the north of Scotland, delivered as part of the largest electricity infrastructure programme the region has ever seen.</p> <p>From 1 September, groups throughout SSEN Transmission’s network area can apply for a share of the funding being released from the company’s opening £10m Regional Community Benefit Fund, from a minimum amount of £40,000 up to £500,000.</p> <p>The deadline for applications is Friday 22 November, and decisions will be made in January 2025. Details of how to apply and eligibility requirements are available at <a href="https://ssen-transmission.co.uk/communitybenefit">ssen-transmission.co.uk/communitybenefit</a>.</p> <p>The launch of the Regional Fund is expected to be followed early next year by the launch of local funds dedicated to communities situated close to new infrastructure developments.</p> <p>Based on initial indications from the UK Government, SSEN Transmission anticipates that over £100m in community benefit funding will be delivered in communities through its £20bn investment to upgrade the transmission network across the north of Scotland in support of UK and Scottish Government net zero and energy security ambitions.</p> <p>Following <a href="#">extensive consultation with the public in 2023</a>, the company has confirmed that priority for funding from its Regional Fund will be given to projects that deliver on one or more of three identified themes:</p> <p>People: focusing on skills, training and employability;  Place: emphasising the community and culture of the north of Scotland; and  Reducing fuel poverty levels.</p>

<p><a href="#"><u>AVIVA COMMUNITY FUND – CROWDFUNDING REQUIRED</u></a></p>	<p><b>Ongoing</b></p>	<p>Grants up to £50,000 are available for not-for-profit organisations in the UK who can raise their initial funding through a crowdfunding campaign for projects that address Aviva’s current themes of climate champions and financial empowerment.</p>
<p><a href="#"><u>AWARDS FOR YOUNG MUSICIANS</u></a></p>	<p><b>Anytime</b></p>	<p>Awards for Young Musicians supports outstanding young instrumentalists making music in any genre. If you can clearly show that you are talented and committed and that you need financial help with your music costs then you can apply for an Award of up to £2000. The average award in 2020 was £550. Young musicians aged between 5 and 17 years of age and are living and studying in the UK are eligible to apply.</p>

<a href="#"><u>BANK OF SCOTLAND FOUNDATION</u></a>		<p>Bank of Scotland Foundation, has announced the launch of its new five-year strategy - "Building a Brighter Future for Scotland." The strategy aims to fund, support and champion small and local charities that work towards improving the quality of life for some of Scotland's most vulnerable people.</p> <p>The first multi-year programme under the new strategy, Empower, will launch in early February, offering real security and certainty for charities. This programme will offer a three-year unrestricted grant of £150,000 (£50,000 per annum) and collaborating with Lloyds Banking Group, the Foundation also aims to identify opportunities to add strategic value for funded charities and help them grow stronger and thrive beyond the lifetime of their grant.</p> <p>Two further multi-year programmes will be launched later in the year. Energise is a multi-year grants programme supporting small and local charities that are closest to the real issues facing our communities. Available to new (and more established) charities this programme offers a two-year unrestricted grant of £20,000 (£10,000 per annum), enabling charities to use their grants in the way that helps them best.</p> <p>The third programme, Enable, is an innovative, joint grants programme with the Foundation's sole funder, Lloyds Banking Group, aimed at boosting community volunteering. Funding will be provided to charities to support projects delivered through volunteers, with Lloyds Banking Group's colleagues across Scotland volunteering their time and skills to help deliver the projects and support the charities.
