SCOTTISH GOVERNMENT TO CONTINUE PVG FEE WAIVER FOR VOLUNTEERS

Good news! The Scottish Government will continue to provide free Disclosure Scotland Protecting Vulnerable Group (PVG) scheme membership to volunteers following a public consultation on fee waivers and discounts in 2024.

This decision by Scottish Ministers recognises the vital role volunteers play in Scotland's society with roles in care, health, sports, community and children's recreational activities. Membership of the PVG scheme provides assurance to employers and the public that a person can work safely with children and protected adults. By continuing with the fee waiver, volunteers and charities can continue to consider new opportunities by accessing PVG membership without encountering any financial barriers in doing so.

HMRC ASSISTANCE ON VAT FROM AZETS

HMRC has initiated a process of writing to some smaller charities (up to £2m turnover) to raise awareness of the requirement to restrict recovery of input VAT where that VAT relates in part or in full to non-business activities.

Unfortunately, non-business is one of the trickiest areas of VAT, and one that lots of people find a challenge. <u>SCVO's VAT and tax service</u> partner, Azets, has a significant amount of experience in this area and has assisted many charities and voluntary organisations around the country to confirm their VAT recovery position and resolve HMRC enquiries and challenges. <u>Please contact Azets</u> if you'd like more information on the recovery of VAT or if you are affected by this HMRC campaign.

IMPORTANT CHANGES TO DISCLOSURE SERVICES/ CHANGES TO THE PROTECTING VULNERABLE GROUPS (PVG) SCHEME

From 1st April 2025 the Protecting Vulnerable Groups (PVG) scheme becomes a legal requirement in Scotland. It will be a legal requirement for individuals to be a member of the PVG Scheme when carrying out a regulated role with children, protected adults, or both. Organisations must ensure that individuals who are to carry out a regulated role (paid or voluntary) have PVG scheme membership from 1st April 2025 onwards.

From this date, 'regulated work' will be replaced by 'regulated roles'. Disclosure Scotland expect that roles which are currently included under regulated work, will also be regulated roles. However, the introduction of 'regulated roles' will bring new roles into the PVG scheme that are currently not regulated work. Examples include, football agents, talent scouts, hypnotherapists and certain hospital or hospice-based roles that do not currently qualify for the PVG scheme.

Make Sure You're Ready!

The Disclosure Act will improve the disclosure system in Scotland by removing unnecessary barriers for people with convictions as they seek employment or other opportunities and enhance the Protecting Vulnerable Groups (PVG) scheme. Upcoming changes will be introduced in 1 April 2025 and charities, particularly those who work with vulnerable adults or children, should be aware of what's changing.

THRE – THIRD SECTOR HUMAN RIGHTS AND EQUALITIES

CLIMATE CHANGE AND MARGINALISED COMMUNITIES

Climate change is often discussed as a separate issue to human rights and equalities. But, it is clear that those who are most affected by inequality within society are also those likely to be disproportionately affected by climate change. THRE's latest resource explores some of the ways in which climate change impacts marginalised groups in specific and often, more severe ways, and gives third sector organisations the information it needs to understand this developing issue. This guidance was developed in partnership with GCVS's Climate Friendly Practice Team.

HUMAN RIGHTS AND EQUALITIES FIRST APPROACH: THE BASICS

This course is based on our popular online Zoom training. Using real life examples and interactive learning the course helps you to build an understanding of what is meant by human rights and equalities, introduces key concepts and ideas, and shows you how to bring these into your everyday work and place them at the centre of what your organisation does and how you do it. SAFER SOONER DA NETWORK SUMMARY REPORT FOR 16 DAYS 2024 (PLEASE SEE REPORT ATTACHED TO EMAIL)

The Safer Sooner DA Network has released an event summary for 16 Days 2024 including the latest statistics and reflection on VAWG in the UK today. Please see the report attached for invaluable reflections on 2024 and prospects for the year ahead. See some of the figures available in the report attached.

• Violence against women and girls has been declared a national emergency by the UK government.

• In Scotland, 63,867 incidents of domestic abuse1 were recorded in 2023 24 - a 3% increase from the previous year. Of these, 83% of the victims were female.

• Last year, five women in Scotland were killed2 by a partner or ex-partner.

• 14,602 sexual crimes3 were recorded in 2022-23, with 94% of rape and attempted rape victims and 86% of sexual assault victims being women or girls.

• The number of women and girls killed by men in the UK remains consistent and shocking.
